Advertisement for the recruitment of project staff on a contractual basis for the ICMR-funded project titled “Integrating Telemedicine with Capacity Building to Improve Trauma Care Service in Tribal and Rural Blocks of Central India: A Pre- and Post-Quasi Experimental Study Design” in the Trauma and Emergency department at AIIMS Nagpur

A call for various positions for a research project titled “**Integrating Telemedicine with Capacity Building to Improve Trauma Care Service in Tribal and Rural Blocks of Central India: A Pre- and Post-Quasi Experimental Study Design**” funded by the Indian Council of Medical Research (ICMR) under Dr Soumya Ghoshal (PI).

The total duration of the post is for 11 months initially, extended maximum up to the end project date depending upon the project requirement and performance. Selected candidates are expected to work at Nagpur district.

*These are the minimum qualifications applicable. However, candidates with higher qualifications can also apply. Desirable Qualifications: Prior experience in health-related projects & qualitative research, Proficiency in Marathi, Hindi and English. The Candidates should be well-versed in computers and file management using MS-Office, PowerPoint and Excel, and Google Sheets, Forms, and Docs. Good communication skills.

#The age relaxation for SC/ST candidates is up to a maximum period of 5 (Five) years, and for OBC (NCL) candidates up to a maximum period of 3 (Three) years. (*Submission of the respective community certificate issued by the competent authority is mandatory to claim age relaxation by the applicant.*)

General instructions

- All educational qualification certificates shall be from a recognised Board/University.
- All experience gained shall preferably be from the Government. Organisation and shall be counted after the date of completion of the Minimum Essential Qualification.
- Experience in the relevant field/area required for the study of the Project concerned will be considered.
- All community certificates should be issued by the authorised officers of the Government.

- The required relevant Field/Specialisation may be mentioned in brackets against the position that is to be filled.
- Age relaxation of up to 5 years may be granted to deserving candidates with experience in a Government Research Organisation, on a case-by-case basis, by the DG, ICMR/Head of the Institution.
- The duration of the first appointment will be for 11 months. The contract will be renewed based on the performance evaluation, with the Executive Director's approval. If the candidate is not performing well, they can be terminated with a one-week notice.
- The fixed-term engagement (s), i.e., initial as well as extended, shall automatically cease/conclude if the same is not extended within the tenure.
- No retrospective extension of engagement (s) shall be permissible.

Terms & conditions:

1. The above post/s are filled purely on a contractual basis for a fixed duration under an ICMR-funded research project. These are not the regular posts under ICMR or AIIMS Nagpur.
2. The interview will be conducted in person only.
3. Based on this experience, the selected candidate cannot claim permanent employment with either ICMR or AIIMS Nagpur.
4. In case the candidate wishes to resign from the post, he/she should furnish a 30-day notice.
5. Once the project duration is completed, the tenure is automatically over for the candidate selected for this project
6. Although the total project duration is three years, the appointment is purely project-based and co-terminus with the project. In the event of discontinuation or closure of the project for any reason before its completion, the appointment shall stand terminated accordingly.
7. The candidate should be able to talk fluently in English, Marathi and Hindi
8. No TA/DA will be provided for attending the interview
9. Apart from the salary mentioned and travel claims for fieldwork related to this project, the candidate is not eligible for any other allowances.

All applications will be screened, and only shortlisted candidates will be invited for an in-person interview. An online interview will not be permitted. The date and venue will be communicated within 2–3 weeks of the application deadline. A written or skills test may be conducted before the interview to further shortlist candidates, depending on the number of applications received and the number of candidates scheduled to appear on the interview date. Candidates may also be shortlisted based on their additional qualifications/ work experience.

Important Instructions:

- Applications received after the deadline will not be accepted.
- All notifications related to this project recruitment (eligibility list/interview date, venue/final results/Addendum/Corrigendum, etc.) will be published in the AIIMS Nagpur website only. No personal communication to the applicants will be done. Hence, candidates are advised to check the AIIMS Nagpur website regularly for any information.
- Incomplete applications, applications not submitted in the prescribed format, and applications without the supporting documents requested shall be summarily rejected.
- The offer of engagement will be subject to verification of original certificates as per the advertisement. If the candidate is not eligible, their candidature will be cancelled at any stage of the recruitment process. If the candidate qualifies in the selection process and it is subsequently found that he/she does not fulfil the eligibility criteria, his/her candidature will be cancelled, and if appointed, the services so obtained will be terminated without any notice or compensation.
