 4. Candidates if they are selected will have to produce **original documents** of their qualification age and experience before joining. If they are not found entitled, their selection will be cancelled immediately.
 5. Candidates are advised to visit the Institute's website for any change, result or any other information.
 6. Age will be reckoned from the last date of Notification.
 7. Above post is contractual for the duration offered and may or may not be renewed subject to satisfactory performance and requirement.
 8. Stipend/consolidated emoluments of the project positions may vary from time to time.
 9. No TA/DA will be paid either for interview in person/joining the post. Candidates have to arrange transport/accommodation themselves for these purposes.
