AI-ACIHR Recruitment: Important information, Terms and Conditions

Selection Procedure

- The reporting time for registration of candidates for the walk-in interview is on 22nd July 2026 i.e. Wednesday strictly between 8:00 AM- 9:00 AM.
- Those candidates found eligible in the document verification process will further be evaluated on the basis of interview.
- Interview will be conducted on 22nd July 2026 i.e. same day between 02:00-05:00 PM
- However, In the event of a high volume of candidates (>20), the selection process will be conducted in two phases instead of a direct interview:
 - **Phase 1 (Skill Assessment/screening):** All present candidates will undergo a skill assessment test/screening.
 - **Phase 2 (Interview):** Candidates shortlisted from Phase 1 will proceed to the interview round on the very same day.
- The assessment will be conducted offline in a physical mode.
- Candidates should ensure the eligibility for the given post.
- **Venue-** Seminar Room, Department of Anatomy, 1st floor, Medical College Building, AIIMS MIHAN, Nagpur- 441108.

Note- Candidates possessing the prescribed qualifications and experience are required to appear for document verification and the interview as per the scheduled time. Candidates reporting after the stipulated time, as specified above, will not be considered for registration or the interview

- **Interested candidates must report with the following documents on the day of Interview.**
 - I. Duly filled application form (Annexure 1)
 - II. Self-attested photocopies for submission (two sets): - of proof of date of birth (birth certificate/class 10th certificate), eligibility qualification mark-sheets, degrees, experience certificate, caste certificate (if applicable), qualifying degree registration with statutory council (if applicable) and other relevant testimonials.
 - III. Original certificates for verification (two recent passport size colour photographs and aadhar card (two Self-attested photocopies and original/e-aadhar) failing which he/she will not be allowed to participate in the walk-in-written test.
- Only complete applications will be considered. Incomplete applications or applications without prescribed format will not be considered.
- Should the number of qualified candidates be substantial, a skill assessment/screening may be administered as part of the selection process followed by interview.
- The Skill Assessment test would consist of questions in the subjects of General Science, General Analytical ability, research methodology, and knowledge of concerned area etc.
- No TA/DA will be paid for attending the written test, skill assessment, and interview.

- Note: The post will be governed as per terms and conditions of ICMR and is advertised in accordance with the fund released by ICMR.
- Canvassing of any kind will lead to disqualification.
- The decision of the competent authority regarding the selection of the candidate will be final and no representation will be entertained in this regard.

Eligibility Criteria

- Candidates must ensure they meet all eligibility requirements.
- The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
 - All the educational qualifications/certificates shall be from the recognized Board/University.
 - All the experience gained shall be preferably from the Govt. Organizations / **recognized university/ research institutions** and shall be counted after the date of completion of Minimum Essential Qualification.
 - Experience from reputed national/international organizations will also be considered.
 - Experience shall be from the relevant field/area, as required for the concerned Project.
 - The candidate who is already in government service shall submit '**No Objection Certificate**' from the present employer at the time of assessment/interview.
 - The candidate should not have been convicted by any Court of Law.

Job Description:

Assisting in conducting the project in the form of Literature review, microplanning and data collection, quality assurance & supervision, qualitative interviews, data analysis, report writing & dissemination, selection of other staff, meeting and liaising with government officials, procurement and maintenance tools & equipment, financial record-keeping and any other tasks as assigned by Principal Investigator.

Contract Terms
