- HSN Code of the product needs to be mentioned.
- Rates of articles should be quoted per unit item without including GST.
- Taxes livable should be quoted separately.
- Delivery Period: - Within 30 days from the date of supply order.
- Delivery should be FOR O/o Central Store, AIIMS, Nagpur.
- A declaration by vendor is required to be submitted along with quotation station that vendor is not debarred by Department of Commerce or Ministry/ Department concerned. The date of declaration should not be before the date of NIQ and after the last date of submitted of quotation.**
- Liquidated Damages charges:** - In the event of the Seller's failure supply, Liquidated Damages charges will be deducted to the sum of 0.5% of the contract price of the delayed/undelivered, stores/services mentioned above for every week of delay or part them of a week, subject to the maximum value of the Liquidated Damages being not higher that 10% of the value of delayed stores.

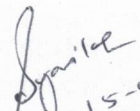

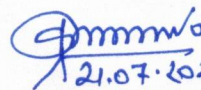

Specification of Trial lens holder for HFA 3 860 Machine

- Specifically designed for Humphrey Field Analyzer 3 (HFA 3) Model 860
- Must be fully compatible with ZEISS HFA 3 860 system architecture
- Should support replacement of Liquid Trial Lens module when required
- Manual Trial Lens Holder (Detachable Type)
- Used for holding standard ophthalmic trial lenses during visual field testing
- Required when:
 - Liquid Trial Lens is not functioning
 - Refractive error is outside automatic correction range
 - Cylindrical correction is needed (>1.75 D astigmatism)
