This is with reference to AIIMS, New Delhi recruitment Notice No. 50/2023 dated: 13.04.2023 regarding recruitment to the post of Nursing Officer on 'Direct Recruitment' basis in various AIIMS through NORCET-2022 and subsequent processes thereof i.e., CBT, Choice filling, uploading of documents on the NORCET-2022 portal, Institute/Hospital allocation and acceptance of Institute by candidates.

2. Based on the verification of documents submitted by candidates on the NORCET-2022 portal a provisional eligibility status of candidates has been prepared and placed as **Annexure- A** for Eligible and **Annexure- B** for partially eligible candidates.

3. All the 'Partially eligible' candidates are mandatorily required to submit documents as mentioned against their name in support of their eligibility by email to nonfac.recruitment@aiimsnagpur.edu.in latest by 01.05.2023, 5.00 P.M. They should email all these documents in a single (merged) pdf file.

4. In case no representation is received from 'partially eligible' candidates within the specified date (01.05.2023) then it will be considered as the concerned candidate is not having any documents/claim in support of his/her eligibility. Such candidates shall be declared 'Not Eligible' for NORCET-2022 without giving any further notice.

5. Representation received after 01.05.2023, through email or any other mode from any of the candidates will not be considered under any circumstances.

6. Offer of appointment to all 'Eligible' candidates who have been allocated AIIMS Nagpur in the 2nd round of seat allocation of NORCET-2022 will be issued shortly.
