2. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the aforesaid post and must fulfill all the eligibility criteria on or before **01/07/2024** failing which their application will be rejected.

The reservation is as per the roster provided by the Ministry of Health & Family Welfare, Government of India.
 5. Based on bio-data, the Scrutiny Committee may shortlist Candidates for interview. The list of eligible/shortlisted candidate and the date of interview will be notified on AIIMS Nagpur website. The employment will be purely on contractual basis and under no circumstances are linked to regular appointments and cannot be regularized at any stage. If the contract is not extended further, the same will lapse automatically.
 6. The emoluments will be consolidated in nature as determined by the competent authority. The appointment can be terminated by the competent authority any time before one year also, without assigning any reason thereof.
 7. **Caste/Category Certificates:**
 - (A) **OBC Category**
 - i. The vacancies are being advertised in financial year **2024-2025**, therefore, valid NCL-OBC certificate issued during the period **from 01.04.2024 to 31.03.2025** will be considered valid. Candidature who have OBC-NCL certificate issued before or after this period (i.e **01.04.2024 to 31.03.2025**) will not be considered valid for this advertisement.
 - ii. Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36036/2/2013-Estt(Res-I) dated 31.03.2016.
 - iii. **Certificate must be valid for employment in Central Government Institutions.** OBC candidate's eligibility will be based on Castes borne in the Central List of Govt. of India. **Their Sub-caste should also match with the entries in Central List of OBC, failing which their candidature as OBC candidate will not be considered.** The OBC certificate should clearly show that the applicant does not belong to the Creamy Layer.

10. The candidate who is already in government service shall submit '**No Objection**

Certificate' from the present employer at the time of Interview.

11. Canvassing of any kind will lead to disqualification.
12. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
13. Private practice of any type is prohibited.
14. The appointee shall not be granted any claim or right for regular appointment to any post of AIIMS.
15. He/She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
16. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available/applicable to the Government Servants, appointed on regular basis.

The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority.
