1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

- 12) Experience of operations and maintenance of water treatment, sewage treatment and effluent treatment for a minimum of 3 years completed prior to the date of bidding the tender.
- 13) Experience of execution and/or operations of operating at-least 2 different technologies for water treatment plant, sewage treatment plant and effluent treatment plant for a minimum of 3 years prior to the date of bidding. The experience for each to be mentioned.
- 14) The bidder who has operated and maintained more number of technologies for WTP, STP and ETP for longer period shall be considered technically well versed and better experienced.

- 16) Experience for public as well as reputed private companies with a verifiable track record is accepted.
