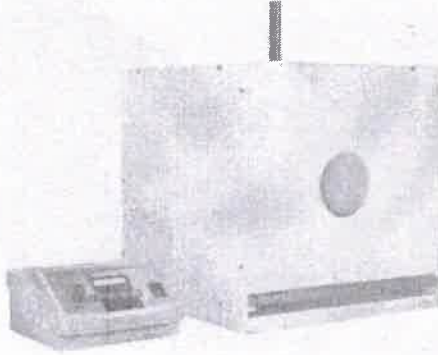

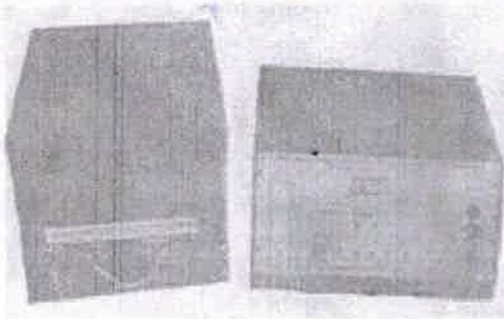
1. Cooks pole climbing apparatus:

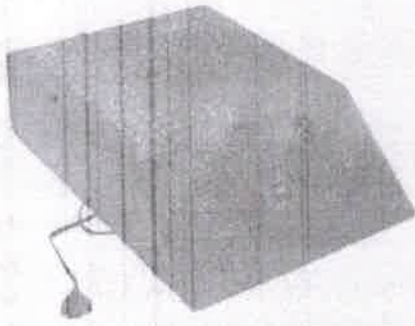
