3. Vendors are requested to submit detailed technical specification of quoted along with broacher.
4. Quotation without technical specification will be strictly rejected.
5. A compliance statement of technical specification need to be submitted along with quotation.
6. Rates of articles should be quoted per unit item without including GST.
