6. Highest Bidder (H1) will be decided on Composite Basis.
7. If a bid is accepted, the successful bidder has to deposit earnest money not less than twenty-five per cent. of the H1 bid value immediately on the spot either in cash or in the form of **Demand Draft, drawn in favour of the Executive Director, AIIMS Nagpur.**
8. The Highest Bidder (H1) has to deposit remaining Auctioned bid value in the form of demand draft in favour of AIIMS Nagpur within 03 days from the date of H1 evaluation.
9. The Highest Bidder (H1) has to uplift the auctioned material within 07 days from the date of deposit/payment of remaining H1 bid value otherwise for the next 14 days 0.5 % per day penalty shall be charged and recovered from the EMD.
